SPECIFICATION OF MATERIALS & SCOPE OF WORK

1. All samples of material and job shall be of best quality and shall be got approved before use.
2. All boards, ply and veneer shall be Greenply brand.
3. Paints shall be first quality of Asian paint, Berger, Nerolac or as approved.
4. Screws shall be Nettle fold.
5. Light fitting shall be Philips unless otherwise specified. If the specific fitting is not available in Philips range, approval for using other make shall be taken in advance.
6. Wood used for any purpose like furniture, frame work, paneling etc shall be teakwood unless otherwise specified.
7. Design to be got provided shall be approved by the Consultant/Engineer in charge.
8. Switches shall be of Legrand make and cable shall be of ISI quality.
9. In all area where furnishing job are to be carried out, whether specifically mentioned or not, shall include.
 - a. Leveling, aligning of walls, ceiling, floors to give a flawless & perfect finish.
 - b. All walls and ceiling whether new or old shall be painted as per direction and wood of doors shall be polished/painted.
 - c. Necessary electrical modification including chase cutting, false ceiling cutting, switches etc and making good the damages.
 - d. Curtains/blinds in doors/windows/openings in the area as per direction including Pelmet/curtain rod etc.
 - e. Door stoppers and door closers.
 - f. Necessary civil or furnishing jobs required for Air Conditioning, Fire and electrical work.
10. Fans shall be of USHA/HAVELLS make long extension rod shall be provided where required.
11. All floor spring shall be 'DORMA' make.
12. In most of the item of B.O.Q. make are specified. If such make is not available, alternative make shall be got approved prior to procurement and use.

SPECIAL CONDITIONS OF CONTRACT

PRICE:

Quoted price shall include, all cost of material labour, transportation, handling all taxes as applicable, incidentals, overheads, profit etc.

PAYMENT:

- ❖ No advance shall be paid. Payment shall be made against work executed.
- ❖ Maximum Two on account and one final bill may be paid.
- ❖ Taxes as applicable shall be deducted while making payment.
- ❖ R.A. Bill shall be paid against presentation of invoice.

SECURITY DEPOSIT:

5% shall be deducted and retained towards S.D. which will be refunded after one year of defect liability period.

COMPLETION TIME:

90 (ninety) days.

MAINTENANCE PERIOD:

Maintenance period (defect liability period) shall be one year from the certified date of completion by C.E.O.

ELECTRICITY:

Shall be allowed to take connection from building. A deduction of 0.25% of the executed value shall be deducted towards electricity charge.

ACCOMMODATION:

No accommodation shall be provided for the worker. However, one room for the site in charge free of charge.
